6. This permit is issued based on the opinion of Bahour Commune Panchayat, Puducherry, vide Letter F.No.6-39/ BCP/NOC/2023-24/799 dt:18.10.2022. (Copy enclosed).
7. The Layout Promoter/Owners shall settle any legal disputes in the Court of law in respect of the title deed and the Puducherry Planning Authority shall indemnity.
8. The layout approval will be revoked if the same has been obtained by furnishing any false information/statement/suppression of facts or misrepresentation of material facts.
9. The layout has to be registered with the Puducherry Real Estate Regulating Authority as per the section 3 of the Real Estate (Regulation and Development), Act, 2016.
10. EWS plots as earmarked in the layout shall comply to G.O.Ms.No.5/2015-Hg, dated 26.02.2015 (copy enclosed).
