Conditions:-

1. The In-principle layout frame work approval is issued based on the details of area relating to the extent of site, sold and unsold plots declared by the Layout promoter/ Owners/Authorized Signatory.
2. The Layout Promoter /Owners/Authorized Signatory shall not encroach any Government land/ canal /road portion adjoining or passing the layout, in any manner.
3. The Layout Promoter /Owners/Authorized Signatory shall be responsible to tally the layout plan on the ground in all respects viz. R.S.No. of the land, extent, boundaries of the layout site, etc.,
4. The Layout Promoter /Owners/Authorized Signatory shall settle any legal disputes in the court of law in respect of the layout for which this In-principle Layout Frame Work approval is issued and the Puducherry Planning Authority shall be indemnified.
5. The In-principle layout frame work approval issued for this layout will be revoked if the same has been obtained by furnishing any false information / statement / suppression of facts or misrepresentation of material facts in the application on which In-principle Layout Frame Work Approval has been issued.
6. Unsold plots in the Layout shall be sold and registered only after remittance of road development charges at the rate of Rs.180 per sq.m of plot area through Demand Draft drawn from any nationalized bank in favour of the Commissioner, concerned Commune Panchayat, payable at Puducherry.
7. The layout has to be registered with the Puducherry Real Estate Regulatory Authority as per Section 3 of the Real Estate (Regulation and Development) Act, 2016.
8. The In-principle layout frame work approval is issued based on the Legal Opinion received from legal counsel of PPA, dated 20.06.2023.
9. The condition stipulated in the NOC issued by the Revenue Officer (Revenue) South, Office of the Deputy Collector, Villianur, Puducherry vide No. 1878/DCRS/B4/PPA/2023/2312, dated: 09.10.2023 should be strictly adhered to.
10. The condition stipulated in the NOC issued by the Director, Directorate of Survey and Land Records, Puducherry, vide No. 6464/DSLRL/ADOS/2023, dated: 06.10.2023 should be strictly adhered to.
11. Roads have been handed over to Commissioner, Nettapakkam Commune Panchayat as confirmed vide letter No.13362/Works/NCP/2023, dated 28.11.2023. (Gift deed registered vide No.35416, dated 22.11.2023). The conditions stipulated in the NOC issued should be strictly adhered to.
