With reference to your application No. Nil, dated **04<sup>th</sup> October 2023** for the grant of permission for Proposed formation of Residential layout with 9 plots at R.S.No.116/6C, Olavaikal Revenue Village, Villianur Commune Panchayat, Puducherry. I have to state that the same has been permitted as per plan enclosed subject to the following conditions:-

1. The Layout Promoter /Owners shall not encroach any Government land/ canal /road portion adjoining or passing, through the layout, in any manner.
2. The Layout Promoter /Owner shall settle any legal disputes in the court of law in respect of the title deed and the Puducherry Planning Authority shall be indemnified.
3. The layout approval will be revoked if the same has been obtained by furnishing any false information / statement / suppression of facts or misrepresentation of material facts.
4. This approval is issued based on the opinion of the Revenue Officer, Office of the Sub Collector (Revenue) South, Villianur vide No. 6144/SCRS/B4/PPA/LO/TOV/2023/284, dated 15.02.2024.
5. This approval is issued based on the opinion of the Executive Engineer, Irrigation Division, PWD, Puducherry, vide No.3643/PW/EEI/DB/C-19/2023-24/2603, dated 30.11.2023.
6. This approval is issued based on the opinion of the Executive Engineer, Electricity Department, Puducherry, vide No.4438/ED/EE-R(N)/TECH/F.TO/2023-24, dated 08.12.2023.
7. The permit issued based on opinion offered by the Legal Advisor, PPA dated 09.04.2024.
8. This approval is issued based on the opinion of the Directorate of Survey and Land Records, Puducherry, vide letter No.6817/DSLRL/ADOS/2023 dated 17.05.2024.
9. This approval is issued based on the opinion of the Office of the Villianur Commune Panchayat, Puducherry vide NOC letter No.20-1/VCP/JE(O)/PPA/2024-25/135, dated 29.05.2024.
10. The layout has to be registered with the Puducherry Real Estate Regulatory Authority as per the section 3 of the Real Estate (Regulation and Development) Act, 2016.
11. The provisions in the G.O.Ms.No.5/2023-Hg dated 18.05.2023 regarding placing of Telecommunication cable in a duct in the layout should be complied.
