1. The conditions stipulated by the Electricity Department, vide Letter No.5932/ED/EE-R(N)/Tech/F.TO/2023-24, dt: 27.02.2024 shall be strictly adhered to.
2. The conditions stipulated by the Commissioner, Oulgaret Municipality, Puducherry, vide Letter No.25-63/AE-I/JE(IN)/OM/2023-24, dt: 24.10.2025 shall be strictly adhered to.
3. The Promoter /Owners shall not encroach any Government land/ canal /road portion adjoining or passing, through the layout, in any manner.
4. The Promoter /Owner shall settle any legal disputes in the court of law in respect of the title deed and the Puducherry Planning Authority shall be indemnified.
5. The approval will be revoked if the same has been obtained by furnishing any false information/ statement / suppression of facts or misrepresentation of material facts.
6. The layout should be registered with the Puducherry Real Estate Regulatory Authority as per section 3 of the Real Estate (Regulation and Development) Act, 2016.
7. Provisions in the G.O.Ms.No.5/2023-Hg dt:18.05.2023 regarding placing of Telecommunication cable in a duct in the layout shall be complied.
