The proposal of **Thiru.Gautam Chatterjee** Power agent of Mr.Tapan Roy, & Somaya Ettouradjame, is to construct a four storeyed residential building with basement floor at R.S. No:74/5, 74/6pt, T.S.No;19, 23, 25/2, 25/1,ward B, Block 14, Pappammal Koil street, Vaithikuppam, Puducherry Revenue Village, Puducherry Municipality, Puducherry. The proposal was examined by the Committee and agreed to in principle, subject to condition that the building permit shall be issued after obtaining the clearance from the Fire Service Department, Electricity Department, & SGWU Agriculture Department, Puducherry.

CASE NO. 49.

The proposal of Thiru.Jayakumar, M/s.Nehru College of Education & Nehru Teacher's training Institute, is construct a three storeyed institution building (D.Ted & B.ed) at R.S. No:49/1 of Thondamantham Revenue Village & R.S.No. 19/3 of Pillaiyarkuppam Reveune Village, Villianur Commune Panchayat, Puducherry. The proposal was examined by the Committee and agreed to in principle, subject to condition that the building permit shall be issued after obtaining the clearance from the Villianur Commune Panchayat, Puducherry.

ANY OTHER MATTERS WITH THE PERMISSION OF CHAIRMAN

The Puducherry Planning Authority Committee felt that by and large the parking area requirements for the special buildings have to be increased. The committee opined that necessary amendments in this regard have to be made in the Building Bye-laws and Zoning Regulations and the same has to be expedited, so as to cope with the increased need.
