Follow up actions taken on the minutes of the previous meeting dated: 11.01.2017

Item No.1

The Member Secretary, Puducherry Planning Authority apprised that the minutes of the Puducherry Planning Authority meeting held on 11.01.2017 were communicated to all members and the same was confirmed. The follow up action taken on the minutes of the previous meeting was apprised to the members of the Puducherry Planning Authority.

Item No.2:-

The consolidated action taken report on the cases placed in the previous meetings from August' 2016 to January' 2017 was reviewed. It was felt that a number of cases are pending to be disposed off by Puducherry Planning Authority for want of NOCs /Clearances from the Line Departments. The matter was discussed with the Members of the Puducherry Planning Authority / Line Departments and the following measures have been suggested:-

- 1) Line Departments should communicate their opinion/views regarding the proposal within fifteen days time from the date of receipt of letter / proposal. In case if the Line Departments fails to communicate their opinion/views within fifteen days time on receipt of the proposal, Puducherry Planning Authority shall proceed with the issue of building plan approval without waiting further for NOCs/Clearances taking into account that the concerned Line Departments do not have any objection on the proposal and responsibilities to be held on the Line Departments, concerned.
- 2) In case if the proposal is forwarded to irrelevant section of any Line Department, the proposal shall be forwarded to the section concerned with copy marked to Puducherry Planning Authority, for necessary follow up action.
- 3) The proposals for which remarks communicated have not been attended by applicant and the proposals for which the fee and other charges has not been remitted for more than fortnight period shall be closed /refused.
