Agenda No; 1. Revision of charges for Compounding of offences:

The Puducherry Planning Authority committee resolved that the compounding charges fixed during the year 1988 shall be increased, since the same is very low. The committee decided to increase the rates of compounding charges for unauthorized construction of residential building as follows:

Revised rates for compounding of offense for residential building

Description of offences	Floor area for every 100sqm or part thereof
Upto Basement	Rs.3,750.00
Upto Sill level	Rs. 7,500.00
Upto lintel level	Rs.11,250.00
Upto roof level	Rs. 15,000.00
Upto roor level	RS. 15,000.00

The committee decided that the compounding the offense of upper floors shall be multiple of the above based on the number of floors. It was further decided for the building other than residential building shall be double as that of the residential charges.

In case of building constructed with deviations in setbacks area but within the permissible as well as within the excess coverage of 10%, the committee decided to impose compounding of offense for residential building as Rs.3,000/- per sqm. For building other than residential the compounding of offense shall be double as that of residential charges.

Further, the committee decided that the ratification of compounding offence for minor and major offense should be followed as per the decision taken earlier in the meeting of the Puducherry Planning Authority held on 29th April 2003.

The committee after detailed deliberation decided to relax the FAR upto 5% and decided that the compounding of excess FAR shall be done as in the case of excess allowable coverage.

The Meeting ended after the Member Secretary proposed vote of thanks.
