

**Extension of Time Line of the Project for preparation of Comprehensive Development Plan for Puducherry Region**

Preparation of Comprehensive Development Plan for entire Puducherry Region has been entrusted with M/s. Sai Consulting Engineering Private Limited, Ahmedabad, by the Puducherry Planning Authority, as per the G.O.Ms. 06/2014 – Hg, dated 17.07.2014 of Chief Secretariat (Hg), Puducherry. The present status / progress of preparation of the Comprehensive Development Plan for Puducherry was apprised in the meeting of Puducherry Planning Authority. It was apprised that the Consultant has completed the Existing Land Use Map and Land Use Register for the Puducherry Planning Area. The progress of preparation of Comprehensive Development Plan for Puducherry and the request made by the consultant seeking extension of timeline of the project for further period of 6 months was also examined. After detailed deliberations, the Puducherry Planning Authority approved the extension of timeline of the project for preparation of Comprehensive Development Plan for further period of 6 months and also approved to release an amount of Rs. 32.62 lakhs, towards 15% of total consultancy fees, as per the Terms of Reference (TOR) and Contract Agreement executed.

The proposal of purchase of one new four wheeler TATA Sumo Gold for the use of Puducherry Planning Authority exclusively for Enforcement Wing was placed before Puducherry Planning Authority and the same was approved.
