

Confirmation of minutes of the previous meeting held on 29.04.2025.

The Member Secretary apprised that the minutes of the Puducherry Planning Authority meeting held on 29.04.2025 were communicated to all members. The members confirmed the minutes. The Member Secretary also apprised the status of demolition of M/s. Siva Vishnu Mahal at ECR, Karuvadikuppam as per the direction in W.P.No.11070/2025 by the Hon'ble High Court, Madras.

The Member Secretary informed the committee that as the Puducherry Planning Authority committee meeting is being held after a gap of four months, few proposals are placed in this meeting without obtaining NOC's from the line departments against the decision taken in the earlier meeting.

The Member Secretary also apprised the committee that the period of engagement of legal advisors to the Puducherry Planning Authority ended on 31.07.2025. The JTP's informed that the Technical Staff of Puducherry Planning Authority are not competent to examine the documents submitted by the applicants. The services of Legal Advisors are required at least to examine document types such as Settlement, Will, Partition and such.

The chairman informed that in the proposed amendment to the building By-Laws, verification of property details may not be required as it is proposed to be done with Auto Scrutiny with self-declaration model. Until amendment to the By-Laws (or) alternate arrangement is made, only critical documents may be referred for legal opinion.
